YOUNG TALENTS WITH EXPERIENCE ABROAD

The Dean of Research and Graduate Studies at the Federal University of Rio Grande - FURG, in the exercise of his attribution and in line with FURG's Institutional Internationalization Project

(<u>https://print.furg.br/en</u>) and to CAPES Institutional Internationalization Program, makes public the Internal Call for selection of 2 scholarships of six months each, for **Young Talents with Experience Abroad (YTEA)**, linked to the Graduate Programs (PPG) participating in the referred international cooperation projects (ICPs).

1. GENERAL CONDITIONS

- 1.1 The selection of applicants for YTEA scholarships is open to young researchers, Brazilian or foreign, **leaving out of Brazil**, with relevant international academic-scientific experience, proven within the scope of ICPs, to carry out research, teaching and extension in a specific Graduation Program.
- 1.2 The granting of funding to selected applicants is subject to compliance with the procedures, requirements and schedules informed by CAPES.
- 1.3 The implementation of the **YTEA scholarships** within the scope of the PrInt/FURG Program, after institutional selection, is the responsibility of CAPES, which is responsible for financing it, following its specific rules.

2 THE NUMBER AND AMOUNT OF SCHOLARSHIPS

- 2.1 Applications must clearly indicate which ICP and Graduate Program will apply and which PrInt/FURG objectives (https://print.furg.br/en/) will be contemplated from the Work plan.
- 2.2 Table 1 lists the number of quotas available for the year 2023 (must start in October, November or December 2023), according to ICP and provided for in the CAPES-PrInt/FURG Program.

2.3 The selected candidates will receive the scholarship according to the table of values established by CAPES:

- a) Scholarship, proportional to the granting period:
 - BRL 8,000 per month;

c) Health insurance, proportional to the concession period:- BRL 400 per month;

d) Installation allowance: BRL 2,200

3 REQUIREMENTS AND RESPONSIBILITIES

3.1 From the Graduate Programs

a) The Graduate Programs linked to PrInt/FURG must promote wide dissemination of this call among their professors, students, and graduates.

3.2 Institutional Cooperation Projects (ICPs)

3.2.1 Establish a Selection Committee chaired by the coordinator of each PCI in this public notice and a representative of each Graduate Program participating in this Project.

3.3 From the Selection Committee

a) Coordinate the selection process, according to the rules of this call;

b) Prepare the minutes of the selection process;

c) Forward the minutes of the process to the FURG' Steering Committee (print@furg.br) for the dissemination of the preliminary result.

3.4 Steering Committee

a) The PrInt/FURG Institutional Project Steering Committee will be responsible to approve and disseminate the preliminary and final list of candidates selected for the implementation of scholarships by CAPES;

b) Analyze the appeals filed;

c) Forward to PROPESP the documents of the approved candidates, which will be responsible for archiving them for five years.

3.5 Candidate

Candidates for the YTEA scholarship must meet the following mandatory conditions:

- 3.5.1 To have a doctorate of up to ten years counting from the date of the doctorate diploma until the final date of enrollment in this public notice;
- 3.5.2 To demonstrate experience, of at least 12 months, in a teaching and/or research institution abroad. This period can be cumulative, but a minimum of 06 months of professional experience linked to a research/higher education institution abroad is mandatory after obtaining a doctorate (as a post-doctorate);
- 3.5.3 To have resided abroad for the last six months, at least.

4 REGISTRATION

4.1 Candidates must send the following documentation, scanned in PDF format, to **print@furg.br :**

- a) Application form (Annex I);
- b) Copy of the Doctoral Diploma;
- c) Proof of working time abroad and of being linked to an international institution in the

last six months;

d) Curriculum Lattes, in the <u>customized model (production from 2013 onwards);</u>

e) Work plan in Portuguese or English, with a maximum of 5 pages (excluding the list of references), margins of 2.5 cm, written in Times New Roman 12 font, with 1.5 spacing and, obligatorily, containing the items below :

I)Justification of the proposal, demonstrating the topicality and relevance of the research and teaching theme to be addressed, highlighting the importance of the subject for the development of Research and Graduate Studies at the University and for which sustainable development objectives of the 2030 Agenda it will contribute;

- II) Goals;
- III) Description of research, teaching and extension activities;
- IV) Schedule of activities;

V) Contribution of the Young Talent grant to strengthen FURG's collaboration and internationalization networks;

VI) Linking the work plan with the international cooperation project (PCI) of PrInt/FURG;

VII) Expected results with the forecast of obtaining academic and/or technological products from the scholarship in Brazil;

VIII) Relevance of the grant for scientific, technological, economic development, social welfare or improvement of environmental quality.

5 SELECTION

5.1 For the selection process, the PrInt/FURG Internal Selection Committee will take into account the following aspects:

a) Meeting the candidate's requirements at the time of registration;

b) Adequacy of the documentation presented by the candidate to the requirements of this Notice and CAPES rules.

5.2 The selection will consist of evaluating the curriculum (50% of the grade) and the work plan (50% of the grade), according to the following criteria:

6 **RESOURCES**

6.1 Requests for appeals to the Management group must be send with the PrInt/FURG Management Group, sent by email to print@furg.br, within one day after the announcement of the preliminary result by the Steering Committee.

7 APPROVAL

7.1 The PrInt/FURG Management Group will check the documentation in item 6.1 and approve the final list of approved candidates, observing the appeal deadlines.

7.2 The final list of approved candidates and substitutes will be published on the PrInt/FURG website and by the PPGs involved.

8 REGISTRATION OF SCHOLARSHIP HOLDERS AND IMPLEMENTATION OF SCHOLARSHIPS

8.1 The registration of selected scholarship holders must be carried out by the Coordinator of each International Cooperation Project (ICP) of PrInt-FURG, through the System for Granting Scholarships and Aid (SCBA).

8.2 The implementation of the grants is the responsibility of CAPES, which will contact the grantee and open a DIRECT LINE for communication with the grantee.

10 AFTER THE TERMINATION OF THE SCHOLARSHIP

10.1 After the end of the scholarship period in Brazil, the scholarship beneficiary must forward the documentation regarding the rendering of accounts to CAPES.

10.2 The scholarship beneficiary must send the final report to the PrInt/FURG Management Group, within a maximum period of 60 (sixty) days from the end date of the scholarship, containing a maximum of 10 pages. At least the following items must be included in the report: description of activities, submission or publication of an article/patent deposit.

10.3 The scholarship holder must send to the PrInt/FURG Management Group a video in English describing the main results obtained for dissemination on the official website (<u>https://print.furg.br/pt/)</u> within a maximum period of 60 (sixty) days from the scholarship expiration date. The video must have a maximum duration of 3 (three) minutes and be sent in MOV, MPEG4, AVI or WMV formats, with 720p quality, with the camera positioned horizontally.

11 FINAL DISPOSITIONS

11.1 This announcement, as well as the list of selected candidates, and any additional information will be published on the PrInt/FURG page (<u>https://print.furg.br/pt/</u>).

11.2 Those contemplated in this Public Notice must refer to the funding granted by CAPES, within the scope of Public Notice No. 41/2017 Institutional Internationalization Program - CAPES-PrInt, whenever the results obtained are disclosed, mentioning in the language of the work: "*The present work was carried out with the support of the Coordination for the Improvement of Higher Education Personnel - Brazil (CAPES), within the scope of the Capes-PrInt-FURG Program, - Financing Code 001*".
